Terms and Conditions

- 1. The Competition Period runs from 00:00:01am GMT June 11, 2012 until 11:59:59 pm GMT October 31, 2012.
- 2. Eligibility: This competition is open only to persons 18 years of age or older at the beginning of the Competition Period. The entrant must own a valid passport and have no restrictions, legal or otherwise which would prevent them from being able to travel to or enter the USA for the period of April 7-12 2013. The entrant must also be the authorized user of the valid email address used to enter the competition.
- 3. How to Enter: Complete the submission form including a valid shipping address. Confirm that you accept these competition Terms and Conditions. Sign the copyright transfer form. The entry must not: (a) violate any third party rights, including, but not limited to, copyrights; (b) contain defamatory or threatening statements; (c) be obscene or indecent; or (d) have been entered in any other contest or have been published or distributed in any other media.
